Chair Tiena Fletcher called the Department of Human Services' (DHS) Board meeting to order at 1:51 p.m. on September 17, 2014.

#### **APPROVAL OF MINUTES**

With regards to DHS Board Meetings, we meet every other month and we will continue to meet every other month, but it seems that we have had to add a Special Called Meeting in the month of August to present and vote on the DHS Budget before it is due to the Governor in September. #### **COMMISSIONER'S REPORT**

Commissioner Keith Horton reported that Dr. Aneja departed the agency and moved to California to be with her family, and stated that we now have a vacancy for a Medical Director.

Commissioner Keith Horton commented that Johnanna Weathers was very modest in her report about the OHRMD award (received from DOAS). The OHRMD award is for the highest percentage of completion for Performance Management Plans. DHS currently has 8,000 employees and a 97% completion rate which is historical. This is a monumental award for the agency.

Thus concluded the Commissioner's report.

#### CHAIR'S REPORT

Chair, Tiena Fletcher stated congratulations to us on the OHRMD award, and commented that people do not understand the good work DHS does. She stated she knows it does not come without hard work, but to achieve the kind of awards we have been receiving is good work.
