**Notice of Intended Action and Public Hearing Regarding Proposed  
Amendment of Ga. Comp. R. & Regs. 290-2-28-.07 Regarding the  
Temporary Assistance for Needy Families (TANF) Program  
Hearings and Appeals**

**To All Interested Persons and Parties:**

The Georgia Department of Human Services (the “Department”) proposes the amendment of a rule within Chapter 290-2-28 of the Rules of the Georgia Department of Human Services related to the Temporary Assistance for Needy Families (TANF) Program. The proposal would amend Rule 290-2-28-.07, entitled “Hearings and Appeals.” The Department will be accepting written comments regarding the proposed amendment from July 6, 2020, through August 5, 2020.

the proposed amendment. At the public hearing anyone may present data, make a statement, comment or offer a viewpoint or argument whether orally or in writing. Lengthy statements or statements of a considerable technical or economic nature, as well as previously recorded messages, must be submitted for the official record. Oral statements should be concise and will be limited to 5 minutes per person. Additional comments should be presented in writing. Written comments are welcome.
