The Georgia Department of Human Services (the "Department") proposes the amendment of a rule within Chapter 290-2-28 of the Rules of the Georgia Department of Human Services related to the Temporary Assistance for Needy Families (TANF) Program. The proposal would amend Rule 290-2-28-.07, entitled "Hearings and Appeals." The Department will be accepting written comments regarding the proposed amendment from July 6, 2020, through August 5, 2020.

Lengthy statements or statements of a considerable technical or economic nature, as well as previously recorded messages, must be submitted for the official record. Oral statements should be concise and will be limited to 5 minutes per person. Additional comments should be presented in writing. Written comments are welcome.
