 Division of Aging Services has historically had contact with the GBI where it intersected with LE requesting GBI assistance on Elder Abuse Cases.

 In 2010, DAS in coordination with LE agencies began developing what became known as ACT (At-Risk-Adults Crime Tactics) Certification.



- ACT Curriculum was developed in coordination with:
 - GA Public Safety Training Center
 - GA Peace Officer Standards and Training Council
 - GA Bureau of Investigation
 - Prosecuting Attorneys' Council of Georgia
 - Institute for Continuing Judicial Education of Georgia
 - GA Administrative Offices of te Courts
 - GA Sheriffs' Association
 - GA Association of Chiefs of Police



- October 2011, GBI staff attended Act training in Kingsland, GA
- November, 2011, ACT Class was held at GBI Training Center (largest class to date)
 - Prosecution, Law Enforcement, DCH Healthcare Facility Regulation Division, Resident Advocates, Adult Protective Services, and the Department of Behavioral Health and Developmental Disabilities



- November, 2011 Police arrested a caretaker for abandoning four disabled people in a vacant Barrow County Home – DAS arranged protective services for residents
 - Barrow County Sheriff Jud Smith thinks his investigators have only scratched the surface of what appears to be a network of unlicensed group homes for the mentally disabled. WSBTV, Nov 16, 2011
- DAS Forensics Special Investigations Unit (FSIU) provided technical assistance to GBI in Newton County Investigation of Personal Care Home. DAS arranged for protective services for residents

- February, 2012
 - State Representative Cooper Sponsored HB 1110
 - HB 1110 Health; penalties relative to owning or operating of unlicensed personal care homes; revise provisions
 - Also authorizes GBI to investigate cases of elder abuse, which Representative Cooper said is rampant in Georgia.
 - Signed into law April 19, 2012
 - Effective July 1, 2012



- March, 2012
 - GBI Indicated it was interested in having Agents Act
 Certified
 - FBI requested information from DAS on At-Risk Adult abuse in Georgia, as a result, released nationally a "Situational Information Report" Activity Alert
 - "FBI Atlanta is releasing this Situational Information Report (SIR) to alert law enforcement and private sector partners to an upsurge in cases involving the abuse and exploitation of At-risk adults (adults over 65 and disabled adults over 18)."



- March, 2012
 - Initial meeting with GBI Director Keenan and DAS FSIU regarding unlicensed PCH and Human Trafficking as it might relate to HB 1110.
 - Gwinnett County Police Officer (who received ACT Certification)
 requested a strategy meeting with DAS Forensics Special
 Investigation Unit regarding a pending arrest of prolific unlicensed
 home operator in Gwinnett
 - DAS, Det. Flanagan (Gwinnett PD), Jeanne Canavan (DeKalb Deputy Chief ADA), Tom Caul (SSA OIG) and staff from from DBHDD and DCH, met with Director Keenan and others about unlicensed facilities/hybrid human trafficking.



GBI Director Keenan

- May 2012
 - Director Keenan briefed Governor's staff about At Risk Adult Abuse, Neglect and Exploitation
 - GBI indicated that all involved LE Agencies, State and Federal Departments will need to work collectively to find the best approach to:
 - "Seek them out" (bad guys)
 - "Rescue them" (victims)
 - Requested initial work group meeting

- Emergency shelter for at-risk adult victims
- Training
- Preservation of victim's testimony
- Agency policies restricting data sharing
- Background checks personal care home owners
- Current GA law requiring mandated reporters to report to non-emergency responders
- Frequent moving of clients (unlicensed facilities)



Outcome of Works Group to Date

- Regular meetings of the Abuse, Neglect & Exploitation (ANE) Working Group coordinated through the GBI
- Strike Force Coordination on PCH raids across agencies
- Local, State and Federal Agencies consistently communicating on ANE
- Obstacles to coordination and prosecution of crimes identified
