State Units on Aging



SUAs are responsible for developing and administering a **multi-year state plan**

- Georgia on a **four-year** cycle
- Follows the federal fiscal year

We are in the final steps:

- Send to ACL for draft review and WK0 feedback
- Internal review and edits by leadership
- Send to Governor for signature
- Submit to Administration on Community Living
