Sanction Options:

- Imposition of fine (lowest allowable for initial, middle of allowable range for subsequent, highest allowable for repeat violations) per incident* or per day
- Public reprimand
- Limitation or restriction of a license
- Suspension of license
- Prohibition of persons in control
- Revocation of license
- Denial of application or renewal of license
- Emergency relocation of residents
- Placement of a monitor

*Multiple violations resulting from the same act, omission, incident, circumstance, or conduct, are not charged per violation, but are charged at the highest category for which a violation is cited as a result of that act, omission, incident, circumstance, or conduct
