- Property Acquisition Resolution
- DCSS Proposed Rule Changes



# **Property Acquisition Resolution**

- Five acres currently owned by Cherokee County, Georgia
- Site of county Division of Family and Children Services (DFCS) and Division of Child Support Services (DCSS) building
- State Properties Commission intends to identify a developer for the property through a competitive RFP process to design, construct, maintain and finance the property
- Approximately 40,000 square feet
- Upon completion, DHS will be responsible for furnishing the building

# **Rule Change Procedure**

- 1. Board Considers Motion to Publish Proposed Rule
- 2. 30-Day Public Comment Period
- 3. Public Hearing
- 4. Motion for Final Adoption of Proposed Rule
- 5. Send Final Rule to Secretary of State



### **Annual Maintenance Fee**

\$25 Yearly Fee Once DCSS Distributes \$500 SB 137 – O.C.G.A. **§§** 19-11-6 & 19-11-8

### Current Rule:

- Custodian Charged \$12
- Noncustodial Parent Charged \$13

#### Rule Published December 1 – 31

### Proposed Change:

- Noncustodial Parent Charged \$25
- Complies with Statute Change
  that was effective October 1, 2017

#### Public Hearing January 10



## **Federal Tax Offset Fee**

Charged by Federal Government on Every Federal Tax Offset Federal Regulation Allows States to Withhold Fee from Offset Federal Fee Increased to \$19.51 Per Offset

Current Rule:

- DCSS Withholds \$15.00
- Shortfall of \$4.51

#### Rule Published March 1 – 31

### Proposed Change:

- DCSS Withholds \$25.00
- Maximum Amount Allowed
