#### To All Interested Persons and Parties:

The Georgia Department of Human Services (the "Department") proposes the creation of Chapter Rule 290-1-9 to be added to the Rules of the Georgia Department of Human Services, Administration. The proposal would create a new chapter section and a new rule: 290-1-9-.01, Safe Place for Newborns Act Signage. The Department will be accepting written comments regarding the proposed rule amendments from August 23, 2018, through September 21, 2018.

A public hearing is scheduled to begin at 10:00 a.m. on September 12, 2018, in the Board Room on the 29<sup>th</sup> floor of 2 Peachtree Street NW in Atlanta, Georgia to provide the public an opportunity to comment upon and provide input into the proposed rule amendments. At the public hearing anyone may present data, make a statement, comment or offer a viewpoint or argument whether orally or in writing. Lengthy statements or statements of a considerable technical or economic nature, as well as previously recorded messages, must be submitted for the official record. Oral statements should be concise and will be limited to 5 minutes per person. Additional comments should be presented in writing. Written comments are welcome. To ensure their consideration, written comments must be received by the Department on or before September 21, 2018. Written comments should be addressed to Daphne M.
