History

• Division of Aging Services (DAS) has contracted with Department of Community Health (DCH) since 2011 to provide Money Follows the Person (MFP) program transitions and options counseling services.

• The MFP grant is intended to move individuals who wish to participate, from nursing homes back to community settings.

• DCH received the MFP grant in 2008 from the Centers for Medicare and Medicaid Services and will continue transitions through September 2020.



History

- Grant funding for DHS DAS has averaged an estimated \$3,800,000 per year since 2011.
- Each year, DAS and contract agencies have surpassed the DCH goal for Money Follows the Person of 125 transitions (average = 190).
- The average savings to Medicaid for individuals in Georgia is \$1770 per month or over \$21,000 annually.
- Many individuals identified as wanting to transition did not meet the MFP eligibility criteria.



Nursing Home Transitions Year One

- In State Fiscal Year 2017 DHS DAS received \$1,000,000 through a legislative appropriation for "non-MFP" transitions.
- DAS contracted with Area Agencies on Aging (AAAs) and Centers for Independent Living (CILs) to provide transition services.



Nursing Home Transitions Year One

- Goal of 167 individuals set by Legislature
- Eligibility Criteria developed for Nursing Home Transition (NHT) program:
 - Minimum 30-day stay in facility
 - Income
 - Risk Assessment Tool score
 - Age 55 or older
 - Proof of citizenship or legal status



Nursing Home Transitions Year One

- Number with NHT: 166
- Number after working with a Transitions Coordinator: 14
- Average cost per transition is \$1200.00
- Most common use of NHT funds that remove barriers:
 - Wheelchair ramps making home accessible
 - Grab bars for bathrooms and showers
 - Medical equipment



Nursing Home Transitions Year Two

- Lessons learned in Year One led to policy revisions for Year Two
- Monitored quality of Year One transitions in AAAs
- Number transitioned as of 2/28/2018: 124
