### **PAC: Vision and Mission**

### **Mission**

The PAC assists in transitioning chronic non-payers of child support to financial self-sufficiency and parental responsibility by addressing the underlying issues that hinder their ability to support their children.



### What Is the PAC Program?

- The Parental Accountability Court is a collaboration between Superior Court Judges and the Georgia Department of Human Services, Division of Child Support Services.
- The PAC program provides judges with an alternative to incarceration in civil contempt cases and encompasses vocational, educational and mentoring concepts.
- The program makes use of existing resources within the local community and reduces incarceration costs for those same communities.
- Judicial oversight encourages compliance with program requirements, resulting in long term fulfillment of child support obligations and financial self-sufficiency.



# PAC: Who Is Eligible

- Those with an open DCSS case
- Those who have a pending contempt, arrest order, or are in custody
- Those who are not considered violent offenders



## **PAC Implementation**





### **PAC Program Phases**

#### Intake

- Complete forms, interviews and assessments
- Provide required documents
- Referrals to Service Providers
- Driver's License Reinstatement Review

#### Phase I

- Meet with coordinator as specified
- Compliance with service providers
- Complete weekly verifiable job search/training, obtain employment
- Communicate/cooperate with DCSS

#### Graduation

- Successful completion of program requirements
- Increased self sufficiency
- More informed on child support process
- Increased work ethic
- Increased child support payments for children
- 12 month follow up

#### Phase II

- FT employment w/IWO &full payments (6 months)
- Compliance with Service Providers
- **Review for Modification**
- Referral for Access and Visitation if applicable
- Seek legitimation rights if applicable
- Request to negotiate payment on state arrears



### **PAC Incentives**

#### **Participant**

- Alternative to incarceration
- Agency initiated reviews for modifications/ right size orders
- Negotiation of payments on state owed arrears
- Increased financial support for children
- New marketable skills
- Increased self sufficiency

### **Judge**

- Decreased re-offending
- Brief 2-3 minute face to face time with each participant
- A person who participants respect and seek approval from
- Seeks ways to get their attention and challenge participants
- Provides leadership

### **Program**

- Increased child support payments to families
- More frequent reviews
- Collaboration with Department of Community Supervision
- Collaboration with local Community Service Boards
- Incentives to pay off state debt and close case
- Increased compliance with court ordered support





### PAC Results: Evidence-Based Research

### Judicial Council of Georgia: Administrative Office of the Courts (2018)

- Reduced incarceration time
- Monthly child support payments increased 79% for PAC participants
- Participants who received referral-services increased payments by 84%
- Participants with felony record more than doubled their monthly payments
- PAC graduates maintained average monthly payments
- Monthly payments for ultimately unsuccessful participants increased 29%
