## AUDIOLOGY SERVICES FOR INFANTS IN GEORGIA Revised May, 2004

The following is a voluntary listing of audiology practices reporting that they are equipped and prepared to provide for newborns and infants the complete audiology diagnostic evaluation recommended in the *Georgia Universal Newborn Hearing Screening and Intervention Initiative – Recommended Guidelines*.

The listings are presented in three categories: 1) comprehensive - those providing both complete diagnostic audiology services and hearing aid fitting and dispensing for infants, 2) diagnostic - those practices providing complete audiology diagnostic services only (no hearing aid fitting); and 3) hearing aid services only.

The recommended protocol for diagnostic evaluation includes at a minimum the following procedures: diagnostic auditory brainstem response (ABR) evaluation, acoustic immittance measurements, evoked otoacoustic emissions (OAE), and behavior observation audiometry or visual reinforcement audiometry. Additionally, some practices (indicated with a  $\bigcirc$ ) are prepared to perform ABR with sedation, which may be necessary for older infants.

Those providing hearing aid fitting and dispensing are prepared to provide real ear measurements, hearing aid selection and dispensing services, and earmolds.

Practices are listed alphabetically, by county, within each category. If the practice accepts Medicaid, it is indicated by a **\***.

There are pediatric audiologists in Georgia other than those listed that provide some, but not all, services described in the protocols, and/or may serve older children.
