Food not subject to further washing or cooking before serving shall be stored in such a manner as to be protected against contamination. Containers for food storage other than the (f) original containers or packages in which the food was obtained shall be impervious and nonabsorbent and have tight fitting lids or covers. (g) Eggs, pork, pork products, poultry, and fish, shall be thoroughly cooked. Meats, poultry, fish, dairy products, bakery (h) products and processed foods shall have been inspected under an official regulatory program. Food service equipment and preparation (i) areas shall be kept clean and free of accumulations of dust, dirt, food particles and grease deposits.
