Action: Notice of Public Hearing for proposed amendments to Ga. Comp. R. & Regs. 290-2-30: Rules and Regulations Governing the Child Protective Services Information System.

To All Interested Persons and Parties:

The Georgia Department of Human Services (the "Department") proposes amendments to Chapter 290-2-30 of the Rules of the Georgia Department of Human Services, Family and Children Services. The proposal would amend the chapter entitled Rules and Regulations Governing the Child Protective Services Information System. The Department will be accepting written comments regarding the proposed amendments from September 9, 2019, through October 8, 2019.

This notice, together with a copy of the proposed amendments and a synopsis of the proposed amendments, is being mailed to all persons who have requested, in writing, that they be placed on a mailing list.

A public hearing is scheduled to begin at 10:00 a.m. on October 1, 2019, in the Department's Board Room on the 29th floor of 2 Peachtree Street, N.W. in Atlanta, Georgia to provide the public an opportunity to comment upon and provide input into the proposed amendments. At the public hearing anyone may present data, make a statement, comment or offer a viewpoint or argument whether orally or in writing. Lengthy statements or statements of a considerable technical or economic nature, as

well as previously recorded messages, must be submitted for the official record. Oral statements should be concise and will be limited to 5 minutes per person. Additional comments should be presented in writing. Written comments are welcome. To ensure their consideration, written comments must be received by the Department on or before October 8, 2019.
